

Information About Video Surveillance at MESSE ESSEN GmbH

Dear Customers,

According to Arts. 12 ff. of the EU's General Data Protection Regulation (EU-GDPR), we as an operator of a video surveillance installation are obliged to make information about the collection, processing and storage/erasure of your personal data (video recordings) available to you in a precise, transparent, comprehensible and easily accessible form. Thus, we also follow Art. 13, Paras. 1 and 2 of the EU's General Data Protection Regulation and meet our obligation to supply information when collecting personal data from the data subject:

Purpose and Legal Basis of the Processing

(Art. 13, Para. 1c of EU-GDPR):

The purpose of the video surveillance is the optical surveillance of the fair site.

The legal basis is the assessment in the case of a legitimate interest on the part of the responsible agency.

(Art. 6, Para. 1f of EU-GDPR)

Legitimate Interest of the Controller

(Art. 13, Para. 1d of EU-GDPR):

The video surveillance serves to provide protection from theft and miscellaneous criminal acts, e.g. burglary, bodily harm or vandalism. Moreover, the video surveillance serves to control traffic/visitor flows.

Transfer of Personal Data to Third Parties, Abroad or a Third Country

(Art. 13, Paras. 1e and 1f of EU-GDPR):

The personal data is transferred to a service provider within the framework of job processing according to Art. 28 of EU-GDPR.

In addition, the personal data is transferred to third parties in order to solve criminal acts (police / public prosecution office). The personal data is not transferred to abroad or a third country at any time.

Duration of the Storage/Erasure

(Art. 13, Para. 2a of EU-GDPR):

The duration of the storage of the video recordings is max. 14 days. Thereafter, the footage is erased irrevocably.

Data Subject's Right to Information

(Art. 13, Para. 2b of EU-GDPR):
